I specifically acknowledge that the nature of activities involved in the Multi-day Youth Programs have been explained to me before I have signed this liability release, and in that regard I understand and agree to the fact that my child will be participating in a youth training program under the direction of one or more instructors, that my child will be participating in that program with other children of varying ages and abilities, that my child will be expected to ski on varied terrain of differing degrees of difficulty in varying weather conditions and that it will be impossible for SHOWDOWN MONTANA to provide my child with the same amount and degree of individual attention in this program as I, as parent, might provide to my own child. Furthermore, I understand that my child may be riding lifts independently, without individual supervision.
